Agreement to be executed at the time of Admission

1. This agreement is made this day thebetween Father/ Mother / Guardian Mr. / Mrs. hereinafter called the “Guarantor” which expression shall, unless excluded by the context or the meaning thereof, be deemed to include his / her heirs, executors, administrators and legal representatives of the one part on the M.D./ Principal of Kasauli International Public School, Sanwara, (Shimla Hills), HP of the other part.

2. Whereas Class Roll No. daughter / son of (hereinafter called student) of Kasauli International Public School, Sanwara has been admitted for the purpose of receiving education inter alias, on the terms and conditions hereinafter appearing.

3. Now it is hereby agreed by and between the parties here to as follows:-

a) That in consideration of the student being admitted by the Principal Kasauli International Public School, the Guarantor covenants with the Managing Director / Principal that the student will attend KASauli INTERNATIONAL PUBLIC SCHOOL, SANWARA regularly and will observe and comply with all the rules and regulations thereof prescribed and that guarantor, shall pay to the school regularly and promptly and whenever called upon to do so, all the fees and other costs as prescribed.

b) That the placing of students in different classes will be at sole discretion of the MD/ Principal.

c) The M.D. / Principal can, at any time, in the interest of the school, may remove, if in the MD / Principal’s sole discretion, the student has failed to abide by the discipline of the school and his / her continued presence is detrimental to the interests of the other students or the student fails to come up to the academic standard of his / her class when detention in the same class could make the student too old for his / her class.

d) That no fees will be refunded if the said student is required to leave the school during the Term for any reasons other than medical grounds.

e) That the MD / Principal or the School authorities will not be liable for any damage / charges on account of injuries, fatal or otherwise, which may sustained by the student at any time during his / her stay in the school, while taking part in studies, sports treks, tours, horse riding and extra curricular activities or any other form of activity, within or outside the school. This includes travel in school/ hired buses, to and from the school. All expenses which may be required in the treatment of such injuries will be borne by parents / guardians.

f) And if there is any dispute as to the effect or meaning of these present or in any way touching or arising out of these present, the same shall be referred to the sole arbitration of the Secretary of the Managing Committee of KIPS, whose decision shall be final and binding on both the parties and shall not be challenged in any court of law or any other forum / cell, like consumers cell etc.

4. In witness where of the GUARANTOR has set his / her hand the Managing Director / Principal by order and direction of the school authorities has set his hand on the day and the year first above written.
